# Appendix 1

## 2009 in Euro

---

This price list is valid in Europe, Eurasia, the Middle East and the African continent. The prices are subject to change with or without prior notice.

**Service Hours:** The Questel service is available every day. It is interrupted from 3:00 GMT to 3:50 GMT from Monday to Saturday, and from 4:00 to 12:00 French time (CET), on Sunday. The Questel service may be interrupted during 24 hours once a year, for maintenance purposes.

### Service Contract

- **Questel Service Contract Annual Fee:** 367.50 €  
Under the "Questel Service Contract", the user will:
  - receive a UserId and password providing access to the Questel service.
  - have access to the complete set of database Fact Sheets, the Questel Mini Guide, through the Questel homepage at <http://www.questel.com>.
- **Additional UserIDs**  
Additional UserIDs can be assigned to allow different users within the same organization to access the Questel service simultaneously.  
Fee: 52.50 € per additional UserID and per year.

### Conditions and Billing

- **Taxes**  
All rates are in Euros and are exclusive of taxes. Any applicable taxes are payable by the customer.
- **Discount Plans**  
An academic rate is available upon request with proof of searching and educational establishment. For further information, please contact your local Questel representative.
- **Billable Elements**  
Each database use is billed for connect hour, online and offline displays according to prices listed in this publication.  
Online connect time is calculated to 1/1000 of an hour.  
Online connect time for cluster searches is billed according to the databases searched. Questel tracks the real search time spent in each database and bills accordingly.
- **Invoice Threshold**  
The invoice threshold is the minimum amount billable. The invoice threshold is 200,00 € or 10.00 € every quarter. When this threshold is reached, a monthly invoice is automatically generated. If the threshold is not reached, the usage will be transferred to the following month. An invoice will be generated as soon as the threshold is reached, or at least at the end of December.



- **Late Payment Penalties**

All invoices are due on receipt, with a tolerance of 30 days after the day the invoice has been raised. Penalties are rated 0,9% a month.

## Networks, Parking File and Mailing Services

- **Network**

- Internet 12.60 € / hour

- **Parking File**

For each connection to the service, the user will be automatically charged for a thirty (30) seconds of connect time in the QUESTEL Parking file.

The QUESTEL Parking file is charged at the rate of 70.35 € per connect hour.

- **Mailing Services**

Postage is not included in offline display and SDI document charges. It will be invoiced to the user in Euros.

## Special Commands and Features

- **Online Statistical Analysis (MEMS, GET)**

The base charge for use of the MEMS or GET commands is 7,88 € per command execution.

- **Terms Stored to Memory List (MEM STORE)**

The stored list of memory terms is charged at the rate of 4,62 € per saved list, per month.

- **Stored Search Charges (SV SE)**

The stored search strategy is charged at the rate of 4,62 € per saved strategy, per month.

- **Selective Dissemination of Information (SDIs)**

The Selective Dissemination of Information (SDI) Profile automatically delivers by postage (on paper) or by e-mail (electronic format) results for previously established searches.

The charge of SDI Profiles on Questel is calculated on a per run basis. Each record printed is billed at the offline display charge rate of the particular file.

- **Patent Delivery Service (PDS)**

This service offers to deliver by e-mail a facsimile, in PDF format, of one or more patents.

Each patent document is charged at the rate of 3,15 €.

First page and drawings are charged at the rate of 0,53 € each.

- **Legal Display Feature (LEGAL)**

The legal display feature is charged at the rate of 0,63 €.

## PatentExaminer Pricing

PatentExaminer charges include a per-document charge, and a monthly storage charge based on the number of documents you have stored in PatentExaminer at the end of each month.
